The Vendor Trade Show will be in lobby area in front of the show room and meeting room. It is an open area and not securable. There is limited space for vendor tables but there should be enough for a regular SDC show.

Tables will be setup in the area Friday afternoon but due to security conditions it is recommended that you setup early Saturday morning, October 23rd. The Vendor area will be advertised as open Saturday, October 23rd from 10:00 a.m. until 5:00 p.m. The vendor area should be cleared by 6:00 pm the same day.

Vendors will receive a ¼ (4.5 X 2 inches) page add in the program book if copy is provided. If you wish to distribute a catalogue, price list or any other information to the registrants please provide 80 – 100 copies to the above address by October 1, 2010 for inclusion in their packets. You may submit items for the registrants even if you do not have a table.

Sales tax must be collected on all sales made for retail. You may display signs that the sales price includes sales tax or you may add the sales tax to the total of the sales. The current rate is 8.517%. Vendors not holding an Oklahoma Sales Tax Permit are to collect the tax and remit it to the Tulsa Rose Society at the end of the day and it will be submitted for you under our special Permit. Vendors holding an Oklahoma Sales tax permit will be responsible to submit their own tax receipts. The Oklahoma Tax Commission is watching sales at conventions and special events very closely and revised their laws to insure they will get their money. It is recommended that you maintain a record of your sales should a field auditor make a visit.

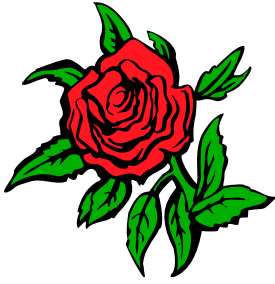
